## Unconditional Income Support (UIS)

### 1. Age 19 (up to 20 birthday)

### 2. ONE of the following applies to you:

- On your 19 birthday, your care status was:
  - Youth Agreement,
  - Continuing Custody Order (CCO), *or*
  - Under the Guardianship of a Director / Director of Adoption
- You spent at least 24 months in care (any status) between ages 12 - 19
- You were adopted/had your custody permanently transferred to someone other than your parent(s) between ages 12 - 19
- You were in comparable arrangements under Indigenous law

## Conditional Income Support (CIS)

### 1. Age 20-26 (up to 27 birthday)

### 2. Attending life-skills, training, educational, vocational, cultural, or rehabilitative programming.

### 3. ONE of the following applies to you:

- On your 19 birthday, your care status was:
  - Youth Agreement,
  - Continuing Custody Order (CCO), *or*
  - Under the Guardianship of a Director / Director of Adoption
- You spent at least 24 months in care (any status) between ages 12 - 19
- You were adopted/had your custody permanently transferred to someone other than your parent(s) between ages 12 - 19
- You were in comparable arrangements under Indigenous law

### SAJE Housing Agreements (SHA)

1. Age 19-20 (up to 21 birthday)
2. On your 19th birthday, you had any government care status, NOT including:
  - Independent Living Agreements
  - Youth Agreements
3. Caregiver must agree

### SAJE Support Agreements (SSA)

1. Age 19-20 (up to 21 birthday)
2. ONE of the following applies to you:
  - On your 19 birthday, your care status was:
    - Youth Agreement,
    - Continuing Custody Order (CCO), or
    - Under the Guardianship of a Director / Director of Adoption
  - You spent at least 24 months in care (any status) between ages 12 - 19
  - You were adopted/had your custody permanently transferred to someone other than your parent(s) between ages 12 - 19
  - You were in comparable arrangements under Indigenous law

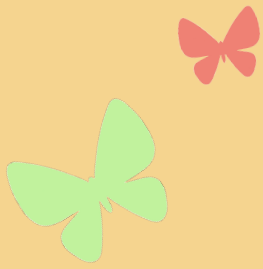
## Rent Supplement

1. Age 20-26 (up to 27 birthday)
2. Renting in the private market in BC
3. **ONE** of the following applies to you:
  - On your 19 birthday, your care status was:
    - Youth Agreement,
    - Continuing Custody Order (CCO), or
    - Under the Guardianship of a Director / Director of Adoption
  - You spent at least 24 months in care (any status) between ages 12 - 19
  - You were adopted/had your custody permanently transferred to someone other than your parent(s) between ages 12 - 19
  - You were in comparable arrangements under Indigenous law

## SAJE Medical and Wellness Benefits

(Medical, Dental, Optical, Mental Health & Counselling)

- Aged 19-26 (up to 27 birthday)
- You are on **ONE** of the following agreements:
  1. Income Support (UIS or CIS)
  2. SAJE Housing Agreement (SHA)
  3. SAJE Support Agreement (SSA)
  4. Agreement with Young Adult (AYA)
